



2023 CRESTWOOD MEMBERSHIP PROGRAM

What better way to promote our Club than through word of mouth from current members? Promoting and advertising our club is at its best through us. The Board of Directors has approved a plan to give our current members the tools to promote the Club. **Recruit a new member, and enjoy a credit to your Club bill.** As an additional incentive, the new member will receive the same credits and an initiation fee waiver with a 24 month agreement.

HERE IS HOW IT WORKS FOR MEMBERS:

- All members will have the opportunity to enjoy a **credit** to their **Club** account. All you need to do is get a prospective member to join and sign their application as a sponsor.
- A current **Social Member** may sponsor themselves to **Golf Membership** status. By sponsoring themselves to Golf status, they will enjoy the applicable 2023 Program monthly credit for **24** months!
- Start a **Legacy** membership for your children who are now **25 years of age** and no longer eligible to participate on your membership and receive the monthly credits.
- **Members** who sponsor a new member into the Club will continue to enjoy the monthly credits to their account for 24 months only if the sponsored member remains as a member for the duration of the 24 months.
- **Members** who successfully sponsor a **new Member(s)** during the **2023 Program** will enjoy 24 monthly credits applicable to the membership classification of the new member. Sponsor **more** than one new member and **reduce your club bill** even more. Here are the monthly credits to successful sponsors:

HERE IS HOW IT WORKS FOR A NEW MEMBER:

- **Under this 2023 Membership Program, initiation fees are waived with a 24 month agreement.**
- As a **new member** you will receive the **2023 Membership Program** credits on your Club account. *(See the table following that shows what a new member realizes from this program.)*
- A potential **new member** will follow the normal procedure to join by filling out a membership application and getting a current member signature on the application.
- **New members** under this program can become **recruiters** and receive a credit in addition to their new member credit.
- Members will be billed according to the membership age chart as they age into the next category.

FAMILY membership shall be comprised of two or more related persons residing in the same house or an individual who is unmarried with dependent children. Dependent children are twenty-four years of age or younger.

SINGLE membership shall be comprised of an individual who is unmarried without dependent children.
