MEMBERSHIP CLASSIFICATIONS

FAMILY MEMBERSHIP shall be comprised of two or more related persons residing in the same house or an individual who is unmarried with dependent children. Dependent children are twenty-four years of age or younger.

SINGLE MEMBERSHIP shall be comprised of an individual who is unmarried without dependent children.

FULL PRIVILEGE MEMBERSHIP

Full privilege membership provides full access to all the Club's dining, swimming, pickleball and golf facilities including involvement in all social activities.

Family Monthly Dues and Fees \$263.00

Single Monthly Dues and Fees \$238.00

INTERMEDIATE MEMBERSHIP

Intermediate membership is available to those between the ages of thirty (30) and thirty-nine (39) years of age, inclusive. This membership provides full access to all of the Club's dining, swimming, pickleball and golf facilities including involvement in all social activities.

Initiation Fee \$750.00

Family Monthly Dues and Fees \$179.00

Single Monthly Dues and Fees \$152.00

JUNIOR MEMBERSHIP

Junior Membership is available to those between the ages of eighteen (18) and twenty-nine (29) years of age, inclusive. This membership provides full access to all of the Club's dining, swimming, pickleball and golf facilities including involvement in all social activities.

Initiation Fee \$500.00

Family Monthly Dues and Fees \$142.00

Single Monthly Dues and Fees \$131.00

⇒ *Intermediate and Junior Members as they progress by age towards Full Privilege Membership will owe no additional initiation fee.*

NON-RESIDENT

Non-Resident membership is available to those whose legal principal residence lies more than twenty (20) miles from the club entrance. Non-Resident provides full access to all of the Club's dining, swimming, pickleball and golf facilities including involvement in all social activities. A monthly din-

ing room minimum is not required. Non-Resident is not eligible for inactive status and initiation fee is non-refundable. There are a limited number of memberships available.

Monthly Dues and Fees \$175.00

VARSITY

Varsity membership is available on a temporary basis during membership drives between the ages of 13 and 18 and must be pursuing membership on a competitive golf team. The membership only includes use of the golf course and golf programs. One year minimum membership require

Monthly Dues \$75.00

LEGACY

Legacy membership is granted to dependents of current members who have reached the minimum age of twenty five (25) and are no longer eligible to participate under a parent membership. **No initiation fee is assessed.**

SOCIAL MEMBERSHIP

Social membership provides full access to all of the Club's facilities and social activities with the exception of golf privileges. This shall include use of the Clubhouse, dining, pickleball and pool facilities.

Initiation Fee \$150.00

Family Social Dues and Fees \$70.00

Single Social Dues and Fees \$50.00

If a member moves from social to a golf membership, the member is responsible for paying the initiation fee difference for that membership type.

CORPORATE MEMBERSHIP

Corporate memberships are available in each membership category and assigned to one party of the corporation. Dues and capital improvement fee vary according to the membership category. Membership may be transferred and assigned to another party within the corporation.

Initiation Fee \$1,000

Monthly Dues and Fees Vary (depending on classification)

All membership classifications are entitled to one vote on club matters with the exception of Corporate, Travel & Varsity. The annual meeting is held the third Monday in January. All fees are subject to change at the discretion of the Board of Directors according to Article V, Section 15 of the Crestwood by-laws.

DUES & FEES

Dues and fees listed within this brochure include a capital improvement fee. An additional voluntary capital fee of \$5.00 per month is available for club improvements.

Written notice is required for any changes to your fees or membership classification.

ACCOUNT BILLING: Dues are billed in advance. All other charges are in the current month. Members will be assigned an account number to use for charges in all departments. The billing cycle for all membership classifications will be based on the calendar month. Payment is due upon receipt of statement. Online payments can be made thru Clubhouse Online using a credit card or Bank Draft. Automatic monthly payments are available to members, at their request thru the club office ; ACH is processed on or about the 10th each month.

EMAIL & SOCIAL MEDIA: It is recommended to keep the club informed of your current email. Current news and information is provided to our members thru our Clubster App via email or mobile notifications. From time to time we also communicate through Facebook and Instagram.

FOOD MINIMUM

All membership classifications with the exception of Non-Resident and Varsity are obligated to a monthly food minimum as follows:

Food purchases apply toward minimum on the calendar month for all membership classifications. This means food minimums must be spent on or by the last day of the month. Legends and pool food apply.

PRIVATE CART OWNERSHIP is available by storing cart on club property or driving private cart on from an adjoining residence with the appropriate monthly fee. No trailers allowed for carts at this time. **PRIVATE CART USERS:** More than one membership using a private cart is available with the appropriate monthly fee. A guest or a member, not participating in a monthly cart program, riding on a private cart will have a half cart rider fee of \$11.00 for 18 holes and \$5.50 for 9 holes.

GOLF PROGRAMS

MEN'S LEAGUE: There is a Men's League held on designated **Wednesdays** during the April through October golf season. Nominal fees are billed upon participation. GHIN handicap is required in some events.

CRESTWOOD WOMENS GOLF ASSOCIATION: Women golfers have the advantage of both a morning (9 & 18) and evening league (9 holes) on **Thursdays**. CWGA fees are \$30.00 annually with participation in either league included.

JUNIOR GOLF: A junior golf program is available on **Tuesday** mornings during June and July. Clinics and play available for juniors (9-17) and pee wee (5 to 8).

COUPLES LEAGUE: A couples program is offered during the golf season by announcement. Other special one night events are available along with a popular weekend invitational, "Bonnie & Clyde" tournament in August.

GOLF COURSE POLICIES AND ETIQUETTE

The golf course of today was designed by architect Floyd Farley. The par 72, 6700 yard layout has large bent grass greens and lush zoysia fairways, strategically placed sand traps and water coming into play on eleven holes. It is truly the greatest golf destination in our area!

DRESS CODE: Please respect our policy regarding proper golf attire. Collared or traditional non-collared golf shirts are acceptable provided not graphic and in good condition. Traditional ladies sleeveless golf blouses or non-collared golf blouses are acceptable. Traditional golf shorts, ladies mid-length golf skirts or pants and hemmed denim are acceptable. Please refrain from tank tops, gym shorts or other non-golf attire. Spike-less golf shoes are required. No steel spikes or athletic cleats allowed.

GOLF COURSE RULES

All players (Members and Guests) must **register** in the Golf Shop.

- Guests must be registered with name and address on our golf course register. A Crestwood member may have multiple guests in the same day. However, a particular guest is limited to one time per month. **(Example non-member John Doe may only play one time per month.)**
- **Members** are responsible for paying or signing for their own golf cart fees. If not staff will bill accordingly.
- All groups are requested to play in under **four** hours.
- **Five** balls in play per group maximum.
- Groups smaller than four may be paired into full groups at the Pro's discretion.
- To be a golf cart operator of either a private or rental, you must have a valid Drivers License or be sixteen (16) years or older.
- Please double up on carts to save cart damage to the golf course.
- The 90 degree rule is always in effect unless **CARTS ON PATH ONLY** signs are posted.
- Play the golf course in the proper sequence 1,2,3 . . . You may begin on #10 at the Pro's permission.
- Please limit your time in Legends at the turn to **five (5) minutes** or less. You must keep your position on #10 tee or you may be required to restart on #1.
- Junior golfers (age 11 and under) must be accompanied by an adult (18 or over) on weekends. The golf shop staff has the right to restrict junior play during busy times that the junior may not be able to handle.
- Tee times are **recommended** seven days a week. They may be booked by calling the Golf Shop (620-231-6530) one week in advance.
- **All food and beverage consumed at Crestwood must be purchased from the club.**

DINING POLICIES AND ETIQUETTE

One of the benefits of our dining facilities is the ability to **"choose your own dining style"**. Our many dining and lounge rooms offer casual, upscale informal and traditional formal dining. Private function space is available from small to large.

DINING SPACES INCLUDE:

FIREPLACE ROOM: Our formal dining area with cloth napkins and tablecloths.

LOUNGE: Our upscale informal dining and bar area.

PAVILION: Our most informal area. Please try to utilize this area for after golf and if dressed at the lower end of suggested dress code.

PAVILION/OUTDOOR PATIOS: Our patios are perfect, *in season*, for evening and pool dining.

LEGENDS (19th Hole): Our snack area before, during and after golf with beverages available to take on the golf course.

RECOMMENDED DRESS CODE: The suggested dining dress code policy is **"Business Casual"**. Formal golf attire, collared dress or casual shirts, logo golf shirts, sweaters and even your dress denim in good condition with finished seams are acceptable. Coat and tie is always an option. CWCC discourages tee shirts, swimsuits, tank and halter tops, hoodies, gym shorts and any garment that has words, terms or pictures. Headgear is discouraged in the Fireplace Room, Main or Lounge.

RESERVATIONS: Advance reservations are strongly encouraged for all dining areas by calling 620-231-9697. Staff are scheduled by reservations. Ample staff will be on hand to provide you with a relaxed enjoyable experience if known ahead of time. A private club unlike a public facility only draws from a relatively limited number.

DINING HOURS OFF SEASON (November through March):

Kitchen closed at 8:00 pm Wednesday & Thursday and 9:00 pm on Friday and Saturday. Legends hours vary by weather and demand. **Calling ahead is always recommended.**

SWIMMING POOL: The swimming pool is open Memorial Day through Labor Day. Closed Mondays for Maintenance. Swim lessons and private pool parties are available upon request. Pool Guest Fee is \$4.00 per guest. Children under the age of 9 shall be accompanied by a responsible party at least the age of 14. **All food and beverage consumed at the pool must be purchased from the club. Food & Beverage Service available poolside.**

PICKLEBALL

Pickleball courts were added in October 2022 for regular and social members as an additional benefit with their monthly dues. Court availability will be during normal business hours.

Paddles and balls will be available to purchase in the Golf Shop. Paddles will also be available to rent at \$5.00 each. Please register your Guests in the Golf Shop. Fees are set at \$7.00 per person.

A Committee has been formed to schedule opportunities for members to learn and participate in programming .

CRESTWOOD COUNTRY CLUB CODE OF CONDUCT

Crestwood Country Club is Southeast Kansas' premier club, and we strive to promote a culture of respect and appreciation for all members, families, guests, and staff. It is the desire of the Club to provide a family friendly, safe and harmonious environment for all to enjoy. Everyone must conduct themselves in a manner consistent with these values.

1. Members will conduct themselves with good sportsmanship in all activities at Crestwood, observing all applicable rules and standards of fair play.
2. Members are responsible for their own behavior, as well as their family members and/or guest. All must comply with Crestwood Code and Conduct policies, bylaws, rules, dress code, and any other common sense conduct standards, whether listed or not.
3. Members shall not engage in activities that might endanger the welfare, safety, culture, or image of Crestwood:
 - a) Destruction of Crestwood property or the property of other members or guests;
 - b) Provoking a fight or argument at any time on club property;
 - c) Causing, creating, or participation in a disruption on club property;
 - d) Use of abusive or threatening language toward a member, guest, or employee;
 - e) Use or possession of illegal substances on club property.
 - f) Possession of a weapon on club property.
 - g) Use of offensive, vulgar, loud language – especially in the clubhouse.
4. Members shall not harass or threaten another member, guest, or employee either verbally, physically, or otherwise.

5. Members shall treat Crestwood staff in a respectful manner, and shall not reprimand or direct staff of the club. Improper tone and language, verbal or physical abuse is not appropriate toward any staff member. A member may express to the employee their service needs, giving that employee an opportunity to fulfill that desired service. However, any complaints or suggestions about employees should first be made to the department supervisor or General Manager, and as a last resort, to the Board of Directors in writing.

6. Members and staff are encouraged to report violations of the Code of Conduct and/or bylaws and rules to the General Manager or the Board of Directors, preferably in writing. Members and staff should always cooperate with Crestwood management and the Board of Directors during the review and/or investigation of an incident or grievance. The Board of Directors, depending on the severity of the violation, may impose any of the following disciplinary sanctions:

- **Dismissal:** The Board may dismiss the alleged violation and take no action.
- **Fines:** When a violation is sustained, a Member may have a fine imposed.
- **Reprimand Letter:** When a violation is sustained, the Board may send a letter of reprimand to the Member, and place such letter in the Member's file for future reference.
- **Probation:** When a violation is sustained, the Board may place the Member on probation for a specific period of time. During this time, if a further incident occurs, an immediate additional penalty may be imposed, the severity of which may be more extensive.
- **Suspension:** When a violation is sustained, the Board may suspend the Member for a specific period of time. During the period of suspension, all Club use privileges may be suspended for the Member, family, and guests. Dues payments (including any assessments and installments that may be due during the suspension) continue to apply.
- **Expulsion:** When a violation is sustained, the Board may expel a Member from Crestwood, permanently forfeiting all membership privileges.
